The covenants for Horizon South Industrial Park are being reviewed; Robbie will schedule a meeting with property owners for mid-October/November to discuss maintenance issues within the park. Recently the Development Authority paid for cleanup, the committee recommends monthly maintenance.

The Development Authority recently received requests for the Greenfield Industries building and four RFI's within the last two weeks. Robbie shared information on a company named CoStar (owner of LoopNet), which is a commercial real estate information company. Robbie recommended a one-year subscription of \$199 a month; the committee approved the monthly expense.
